Our outline for the evening was as follows:

- 1. Terminology and traditions Bill
- 2. Phrasing of music Bill (Wayne playing fiddle)
- 3. Timing Wayne and Dave
- 4. Patter length Wayne and Dave
- 5. Instruction before action Dave, Wayne and Bill

6. Encouragement beyond the College Royal – Bill

I won't repeat here everything that was said. Once the dancers understood that they were not "just a dancer", but that they were the show – the caller can talk until he/she is blue in the face, but without the dancers it doesn't mean a thing – they were really into it. Wayne, also the compulsory caller for the competition, really had their attention. Dave clarified how to use patter. Both of the student callers said that they were really glad for the help.

If you would be interested in having a similar workshop for our own callers and/or for beginning callers, do let anyone on the executive know. And if there are other topics you would like covered, let us know.

Russell's Rambles

Dance terminology can be a tricky thing. I am told that in Modern Western Square, there is a central body that determines what and how movements must be called, much like the Académie francaise in France or the Office de la langue francaise in Ouébec. A great advantage of this is that no matter where you go, the MWS terms will be identical. The words may be English, but the language is "Squaredance" (my own coinage, but probably not the first one to use it). I have heard anecdotally of English-speaking dancers congratulating a Japanese caller only to discover that the latter did not understand a word of spoken English.

In Olde Tyme, which comes from local traditions, the terminology can vary as you travel. In Ontario, there was a certain amount of standardisation in the 40's and 50's. We count the couples counterclockwise. Couples #1 and #3 are the "head couples", #2 and #4 the "side couples", all the way through the dance. In Quebec, the "head couple" is often defined by whoever is active at the time. It can get quite confusing if you are used to the Ontario way of doing things.

The way we play with the breaks, with the caller varying the action – sometimes subtly and sometimes not – is not done everywhere. Many folks keep the same break throughout. I have attended dances where all the caller says is "Allemande left your corner" (or "Main gauche au coin" in Quebec) and everyone automatically follows with a grand chain all the way around, a swing and a promenade. The caller may or may not throw in a bunch of patter. Nobody is really paying all that much attention for the duration, although there is usually a cue to start the promenade together.

Then there is the word "hands". How many? Does the caller want to refer to individual people, as in farm hands or members of a crew? Or does the caller want to refer to the body parts at the end of your arms? How many hands join up for a Circle to the left? For the Dip 'n' Dive, do es a couple join two hands (one each) or do two hands (individuals) join together? Then how many hands are you joining to make a bridge? I'll leave that for you to decide.

Callers Comer

Callers' Corner - submitted by Murray Smith --- from 1997

Fiddle Faddle from Tony Parkes via Jackie Thomson

Opener: All join hands and to the centre fall Once again for the good of the hall.

FIGURE:

Couples 3 and 4 go right and left through First couple go down the centre and divide Lady to the right and the gent to the side And balance four in line Go forward four in line and fall back four

Sashay four behind the right hand couple

Six go forward and fall back six Couple 2 go forward and split the opposite*

Go around one to a line of four (2 lines of 4)

Eight go forward and fall back eight Center two couples wheel once and a half

(Centre couples allemand right oneand-a-half to change places with their partner)

Gents star left, ladies star right Gents pick up your partner with an arm around and star promenade Gents back out, ladies turn in, turn 1 ½, star again.

Home you go to your places all and all swing.

All promenade around the square.

(Repeat dance for couples 4&1, 1&2, and 2&3 starting the right and left through) *Couple 2 splits only the opposite couple, not all six.

Another Call For Callers

DOUBLE BOW KNOT Tune: Tuggerman's Jig, MaJor McKay's Jig

Figure:

Head two couples lead to your right Circle four with all your might Head two gents go back to your places

Three in line we're off to the races Forward 6 and back you trot Tie them up in a double bow knot* The right hand high the left hand under Reverse that knot and go like thunder

Now circle three, yes, circle three And shoot that pretty girl home to me** You swing yours and I'll swing mine

We'll all swing out on the old white pine

*This is like RH high and LH low, but not letting go and the gent turning - followed by LH high and RH low to face the centre again **The side couples circle to shoot the gals back to their partners.

Get to Know Members #15

Who was Jim McGlynn? 1924-2000



Jim was President 1993-1997 Jim, whose father was an electrician, was born in Toronto on February 16, 1924. Jim and his two brothers and two sisters spent their summer days playing lacrosse and baseball in Mimico. His mother would go to Eaton's every Friday night to buy groceries and the food would be delivered the following morning, no charge! His first job was mixing size, white and gum base for a wallpaper manufacturer for twenty cents an hour.

He joined the army at the young age of eighteen and was a tank radioman. His memories of commanding two crews into Normandy would rattle anyone's nerves.

During his army days, Jim took numerous courses, including radio, gunnery, motorcycling, right hand drive trucks, and tanks. After being discharged, he continued with stationary engineering which included pipe fitting, boiler, air conditioning, cooling, motors, relays, compressors, wiring, water treatment, etc. Jim's career has had him working for CIL Pittsburgh Paint, Oakville Wood Products.

Specialties, Liberty Building (an office & manufacturing condominium) and the last five years as the plant manager at Royal St. George's College.

The first time he called a square dance was when Alex Boustead said to him, "I want to dance with Eve, you call the next three". Jim met his late wife at a house and school party where he was asked to call and to demonstrate some old time couple dances. Since Cathy was the prettiest teacher there, he asked her to assist him. Together, they raised a family of three girls, a dog, two cats and a gerbil.

In the early 60's, Jim taught square dancing to grades seven and eight in Long Branch for twenty-five cents per student. With up to twelve sets going, they were able to buy a set of encyclopedias for the school at the end of the year. Jim joined the Callers' Association shortly after it was formed and called at the first big dance. He has been our able and willing President for the last four years and we graciously extend our thanks for his steady hand at the helm and continued support.

FOUNDED 1954

General Information

The Canadian Olde Tyme Square Dance Callers' Association was founded in 1954 by a group of callers interested in preserving, promoting and improving the traditional Canadian style of square and couple dancing.

Members are encouraged to bring guests to any Association function.

This constitution is the property of the Canadian Olde Tyme Square Dance Callers' Association and is for the use of members only.

CONSTITUTION

(Revised October 2017)

ARTICLE I

Name

The organization shall be known as the Canadian Olde Tyme Square Dance Callers' Association (hereinafter called the Association).

ARTICLE II OBJECTIVES

The objectives of the Association shall be:

1. The promotion of friendship, co-operative spirit and mutual assistance among members;

2. The exchange of practical information for improving and preserving the traditional Canadian style of square and couple dances;

3. The introduction of new dances that are in accord with the traditional Canadian style of square and couple dancing.

ARTICLE III MEMBERSHIP

Section 1. Membership shall consist of: (1) Square Dance Callers (Caller Members)

(2) Associate Members who have been duly accepted into the membership of the Association and whose dues are fully paid in accordance with the constitution.

Section 2. A Square Dance Caller shall be a person who has called at dances where the traditional Canadian style of square and couple dancing was a major part of the program and who has qualified under Section 5 of Article III.

Section 3. An Associate Member shall be a person who has contributed in any measure to the instruction, promotion, improvement or support of the traditional Canadian style of square and couple dancing.

Section 4. Each candidate for membership must join the Association as an Associate Member. Applications should be made on the application form approved by the Association and must be accompanied by the initiation fee \$ and the annual membership dues \$ in effect at the time of the application. All applications are subject to approval by a majority vote of the Association Executive at a regularly called Executive Meeting or at an Executive Meeting convened specifically for that purpose.

Section 5. i) Associate Members may apply at any time in writing to the President for admission as a Caller Member.

ii) Applicants shall demonstrate their ability to call a variety of changes to various tempos of music, including jigs and reels, prior to acceptance as a Caller Member.

iii) Applicants shall be assessed by a "Selection Committee", composed of three (3) Caller Members, and appointed by the Executive as required. The assessment will normally occur at a location where the applicant is calling.

The results of the Selection Committee shall be referred by the President to the Executive Committee for acceptance or rejection.

iv) If it is not possible for the assessment to take place at a dance, the applicant may submit three (3) calls to at least one jig & one reel tempos using any available medium (e.g. audio or video tape, CD's etc.) to the President, who will refer them to the Executive Committee for acceptance or rejection.

Section 6. i) The annual membership dues shall be recommended by the Executive and presented

to the membership for approval at any general meeting.

ii) Membership dues for the Association's fiscal year, September 1 to August 31, shall be due and payable each September. Members whose dues have not been paid by the last day of November shall be considered in arrears.

Section 7. Membership in the Association may be terminated in the following manner:

i) By voluntary resignation.

ii) For failure to pay dues or any other indebtedness to the Association, provided that such member has been notified in writing by the Secretary.

Section 8 A member shall qualify for Honorary Membership if he/she has reached the age of 65 years, has been a member of the Association for a minimum of 10 years, and has served in some capacity on the Executive during his/her membership period. The normal membership dues will be waived for such members.

Section 9. Only caller members in good standing shall be eligible to call at the Association's annual spring and fall dances. The executive committee will have the authority to waive this ruling from time to time if they deem it appropriate.

ARTICLE IV OFFICERS

Section 1. The officers of the Association shall be the Executive Committee and shall consist of a President, Vice-President, Secretary, Treasurer, and the immediate Past President.

Section 2. The President shall be the Chairman of the Executive Committee or, in his absence, the Vice-President.

ARTICLE V ELECTION OF OFFICERS

Section 1. The nominations and elections of the officers shall take place annually during the month of June, and shall be conducted by a mail and/or email vote.

Section 2. The officers elected shall assume the duties of their offices immediately on being elected

Section 3 The term of office for the President and Vice President shall be a maximum of two (2) years. At the end of the President's term, it is expected that the Vice President shall stand for election to become President. This does not preclude the possibility that

other interested candidates may also run for the office.

Other offices shall be for one (1) year, but shall not exceed a period of three (3) consecutive years.

Section 4 In the event of a vacancy in the office of the President, the Vice-President will be called upon to assume that office.

ARTICLE VI DUTIES OF THE OFFICERS

Section 1. The President shall preside at all meetings unless he/she otherwise orders, and enforce all laws and regulations of the Association. He/she shall appoint all committees, unless otherwise ordered, and fill vacancies on any of the committees, and, as chief executive shall supervise the work and activities of the Association, and make a general report of such at the end of his/her term.

Section 2. The Vice-President shall perform the duties of the President in case of an absence or resignation of the President.

Section 3. The Secretary shall keep a full and complete record of the proceedings of all meetings at the Association's or Executive's meetings, and record all matters pertaining to the business of the Association which are deemed necessary. He/she shall conduct all normal correspondence of the Association, and shall issue all proper notices relating to the Association at any time requested by the Executive Committee.

Section 4. The Treasurer shall conduct all financial matters of the Association and receive all monies paid into the Association. All cheques for withdrawal of this money must bear the signatures of any two of the following officers; President, Secretary, or Treasurer. Any reports on financial matters must be given at any time requested by the Executive Committee.

Section 5. The Executive Committee shall conduct the business of the Association between general meetings when necessary.

ARTICLE VII MEETINGS

Section 1. The Executive Committee shall call at least one (1) Annual General Meeting of the Association during the 90 day period following the end of the Fiscal Year. The officers shall report on all matters pertaining to the fiscal year just completed, and present plans for discussion for the current fiscal year.

Section 2. Other general meetings will be held from time to time at the discretion of the Executive Committee and on notice from the Secretary.

Section 3. A quorum at a general meeting shall consist of seven members, of whom at least five shall be Caller Members. Any non-Caller members of the Executive shall be counted as Caller members for the purpose of quorum.

Section 4. Mail-in or email voting will be allowed for members unable to attend the Business Meeting in person.

Section 5. Meetings of the Executive Committee shall be called from time to time by the President or at the discretion of the Executive Committee to conduct Association business. A quorum at an Executive Committee meeting shall consist of four officers.

Section 6. The Order of Business at a general meeting of the Association shall be as follows:

1. Reading of the minutes of the previous meeting,

- 2. Report of Offices,
- 3. Report of Special Committees.
- 4. Unfinished Business
- 5. New Business.
- 6. Welfare.

ARTICLE VIII

AMENDMENTS

This Constitution may be amended only by a twothirds majority vote of the fully paid members present at a general meeting of the Association and providing the proposed amendment has been submitted to the Executive Committee and a copy of the proposed amendment has been mailed to all members at least 30 days before the meeting at which the proposed amendment is to be voted upon.

ARTICLE IX DISSOLUTION OF THE ASSOCIATION

In the event of a motion for dissolution being presented, a special general business meeting would be convened by the Executive. In order for the motion to carry, a two thirds majority of members in good standing, in attendance at the meeting, and in favour of dissolution shall be required. If the motion of dissolution carries, three (3) trustees shall be selected from the membership to hold the association assets in trust for a period of six months (6 months).

During this period the trustees shall liquidate all association assets to cash, pay all liabilities, and donate the remainder of the funds to charitable organizations selected by a majority vote of members at the meeting for dissolution.

At the end of the six months (6 months) period, the trustees shall prepare a statement showing the final

dispersements of funds, for distribution to all members in good standing at the time of dissolution.
