In Memoriam



Hazell, Edward (ED) James

August 9, 1929 - May 15, 2018
After a short illness, and a long bout of Alzheimer's. Son of Marjorie and Victor Hazell - Norval. Beloved husband of Liz, father of Edward L. (Audrey), Susan Lloyd (Delmar), Jeff (Lina). Grandfather of Sarah Hazell, Amanda Lloyd, Kevin Lloyd. Born in Queensville, the family moved to Norval when Ed was 8. Ed moved to Brampton at an early age and spent a few years at The Dale Estates working in the flower industry, at 19 he joined Coe Manufacturing (Moore Dry Kiln) making kilns to dry lumber. He worked there for 53 years and retired at 73 when the plant closed. Ed had many interests - restoring Model A Ford cars, beekeeping and woodworking. However, square dancing was his prime love. He worked for Brampton Parks and Recreation teaching children

of all ages in Brampton and the surrounding areas, selecting the best dancers to compete at the yearly Dundalk Square Dance Competition. In the 60s, Ed singlehandedly taught twelve sets of children every Saturday night at Glendale Public School. Ed and his young dancers brought many cups and prizes back to Brampton and they also went on to appear on Barrie TV. Ed had a very distinguished voice and was voted Best Caller in 1962. In the 80s, Ed regularly called at the Four Corners Square Dance Club in Port Credit, never missing a dance in ten years. Ed was a member of the Canadian Olde Tyme Square Dance Callers' Association and also founding member of the Brampton Square Dance Club, where long time Brampton residents will remember attending Saturday night square dancing at Brampton High School.

Frederick Lawrence "Ned" Landry 1921-2018



Frederick Lawrence "Ned" Landry A well-known fiddler past away August 25, 2018 at Ridgewood Veteran's Wing, Horizon Health Network Saint John, NB.

Ned's musical career began at the very early age of four with the Harmonica and his love and interest in music was so great it led to his first Fiddle. As he was unable to read music his talents showed through his keen ears and understanding of the intricacies of various instruments over the years. But his main love was the Fiddle. Ned's radio career began in the early thirty's at CFBO at Saint John and it was while playing on the radio his talents were noted by Don Messer and thus his professional career began at five dollars per show, first with the Harmonica and eventually as second Fiddle. This gradual progression thus led to Ned starting his own band, The New Brunswick Lumberjacks.

Ned and a couple of his band friends decided to join the Army in 1940. After his basic training in Fredericton he was posted to Newfoundland where he spent the majority of service time on duties in the Belle Isle Area. It was here that due to several injuries that led to a medical discharge after three and a half years.

In 1943 Ned continued his musical career and in 1952 Ned received a recording contract with RCA Canada. His career blossomed throughout the 50's, 60's and 70's with many of his own compositions becoming hit tunes throughout the country and western music venues.

During his career Ned has won many honors and awards his first being three time Canadian Open Fiddle Champion in 1956, 1957 and 1962. He became a member of the NB Country Music Hall of Fame on July 2, 1983. He received the prestigious Order of Canada on April 2, 1992. Ned was also inducted into the NS Country Music Hall of Fame on August 18, 2000, and on May 10, 2009 he received a Doctor of Letters from St. Thomas University in Fredericton. He later received the Helen Creighton Lifetime Achievement Award at the EMCA's. Ned was also a lifetime member of the Royal Canadian Legion.

Callers Corner

Many people often ask me what judges look for in square dancing competition. This question varies from judge to judge, but I will

attempt to point out my ranking method.

Some shows allow points for the entrance and/or exit of the set. In this groups are free to be creative. I like to see something original. Some groups build an entrance out of Olde Tyme moves, others involve couple dances. It does not matter, but like other parts of the dance do it well and in time together. Better it be simple and neat then disorganized.

During the compulsory dance I start with full points and usually tick things off for errors. Key things I note: is everyone taking hands at the same time when making circles or grand chains? Is everyone doing the same thing with their loose hand? Are all dancers on the same beat? It doesn't matter which beat the group uses for changes, so long as it is the same one. Most use the one beat, but some do things on a third beat. In dances like the Texas Star, are all couples turning the same way when the break comes? I look for straight lines moving together, and are circles oval shaped? In a circle are all dancers holding their arms up the same way? On a grand square are couples meeting at the same time and reversing together? In a dance like Dive through Pass Through I look to see if the couples are all in line together, and if the inside couples are changing with the outside couples at the same time, or is one side of the square ahead of the other? In dances where two lines face each other for a pass through or right left through, it really shows if half the group is moving faster than

the other. It is also important to take note of when the compulsory caller may make a mistake and not deduct the set. And lastly, a good compulsory caller will start pushing a group harder if they are doing well. This shouldn't result in deductions compared to a group who is not pushed, but in a close competition it allows for a way to set rank two even sets. It is important for judge to realize when the caller is going beyond what he or she has with other groups.

During the optional dance all of the previous points apply. Now is the time for groups to show some creativity. I like to see dances that do not come up as often. I also like to see a well-known dance modified a bit to be new. But, a few things I look for is groups that have brought modern dance calls into Olde Tyme. I don't mind them using a modern dance, but they need to build it out of Olde Tyme calls. I should not hear 'daisy chain', but I can hear 'chain, chain, reverse, reverse, you have done it once now let's rehearse...'. Olde Tyme dance was built on regionalism, and local callers making new dances. So some originality is quite welcome.

Most competitions score for enthusiasm, this is important, at the end of the day did the group have fun? Otherwise it is not worth doing the show.

A few things I don't like seeing in competition judging. One is trying to pick a best couple of all the sets. Usually a judge can see two couples very well, and may a bit of a third,

but never all four. So it is a bit of guess work and I find it hard to be fair. I have sometimes found the categories on the judges sheets to be difficult to apply. For example, Overall Impression. Isn't this the result of judging all the other categories? Or sometimes I have seen Performance and Execution on the same sheet, yet what is the difference?

In the end, judging can come down to a bit of gut feeling based on watching all the groups. A solid smooth group does stand out. And you know that there are two other judges who will hopefully confirm your results, and you arrive at the decision in consultation, which allows for different judging styles to all be part of the results.

Our Constitution

Constitutional Amendments for AGM 2018 (proposed)

1. Article III, section 5 (iv)
currently reads "the applicant may submit *three (3)* calls to at least one jig & one reel tempos"
- change italics to "two (2)"
2. Article V, section 3
currently reads "Other offices shall be for one year, but shall not exceed a period of *three consecutive years.*"
- change italics to "five consecutive years."

If you have requests for any future changes for this constitution submit in writing to the president.



FOUNDED 1954

General Information

The Canadian Olde Tyme Square Dance Callers' Association was founded in 1954 by a group of callers interested in preserving, promoting and improving the traditional Canadian style of square and couple dancing.

Members are encouraged to bring guests to any Association function.

This constitution is the property of the Canadian Olde Tyme Square Dance Callers' Association and is for the use of members only.

CONSTITUTION (Revised October 2017)

ARTICLE I

Name

The organization shall be known as the Canadian Olde Tyme Square Dance Callers' Association (hereinafter called the Association).

ARTICLE II **OBJECTIVES**

The objectives of the Association shall be:

1. The promotion of friendship, co-operative spirit and mutual assistance among members;
2. The exchange of practical information for improving and preserving the traditional Canadian style of square and couple dances;
3. The introduction of new dances that are in accord with the traditional Canadian style of square and couple dancing.

ARTICLE III **MEMBERSHIP**

Section 1. Membership shall consist of:

(1) Square Dance Callers (Caller Members)

(2) Associate Members who have been duly accepted into the membership of the Association and whose dues are fully paid in accordance with the constitution.

Section 2. A Square Dance Caller shall be a person who has called at dances where the traditional Canadian style of square and couple dancing was a major part of the program and who has qualified under Section 5 of Article III.

Section 3. An Associate Member shall be a person who has contributed in any measure to the instruction, promotion, improvement or support of the traditional Canadian style of square and couple dancing.

Section 4. Each candidate for membership must join the Association as an Associate Member. Applications should be made on the application form approved by the Association and must be accompanied by the initiation fee \$ and the annual membership dues \$ in effect at the time of the application. All applications are subject to approval by a majority vote of the Association Executive at a regularly called Executive Meeting or at an Executive Meeting convened specifically for that purpose.

Section 5. i) Associate Members may apply at any time in writing to the President for admission as a Caller Member.

ii) Applicants shall demonstrate their ability to call a variety of changes to various tempos of music, including jigs and reels, prior to acceptance as a Caller Member.

iii) Applicants shall be assessed by a "Selection Committee", composed of three (3) Caller Members, and appointed by the Executive as required. The assessment will normally occur at a location where the applicant is calling.

The results of the Selection Committee shall be referred by the President to the Executive Committee for acceptance or rejection.

iv) If it is not possible for the assessment to take place at a dance, the applicant may submit three (3) calls to at least one jig & one reel tempos using any available medium (e.g. audio or video tape, CD's etc.) to the President, who will refer them to the Executive Committee for acceptance or rejection.

Section 6. i) The annual membership dues shall be recommended by the Executive and

presented to the membership for approval at any general meeting.

ii) Membership dues for the Association's fiscal year, September 1 to August 31, shall be due and payable each September. Members whose dues have not been paid by the last day of November shall be considered in arrears.

Section 7. Membership in the Association may be terminated in the following manner:

i) By voluntary resignation.

ii) For failure to pay dues or any other indebtedness to the Association, provided that such member has been notified in writing by the Secretary.

Section 8 A member shall qualify for Honorary Membership if he/she has reached the age of 65 years, has been a member of the Association for a minimum of 10 years, and has served in some capacity on the Executive during his/her membership period. The normal membership dues will be waived for such members.

Section 9. Only caller members in good standing shall be eligible to call at the Association's annual spring and fall dances. The executive committee will have the authority to waive this ruling from time to time if they deem it appropriate.

ARTICLE IV **OFFICERS**

Section 1. The officers of the Association shall be the Executive Committee and shall consist of a President, Vice-President, Secretary, Treasurer, and the immediate Past President.

Section 2. The President shall be the Chairman of the Executive Committee or, in his absence, the Vice-President.

ARTICLE V **ELECTION OF OFFICERS**

Section 1. The nominations and elections of the officers shall take place annually during the month of June, and shall be conducted by a mail and/or email vote.

Section 2. The officers elected shall assume the duties of their offices on the first day of the new fiscal year.

Section 3 The term of office for all elected offices shall be one (1) year. Each office may be held for up to three (3) consecutive terms (years) before a candidate is ineligible for re-election to that office, for the following year.

This does not preclude the individual from holding that office again in the future. At this point, it is expected that the Vice President will run for the office of President, but this does not preclude the possibility that other interested candidates may also running for the office.

Other offices shall be for one (1) year, but shall not exceed a period of three (3) consecutive years.

Section 4 In the event of a vacancy in the office of the President, the Vice-President will be called upon to assume that office.

Section 5 In the event of a Vacancy on the executive, the remaining executive members have the authority to fill the vacant position by appointment, for the remainder of the current term.

ARTICLE VI DUTIES OF THE OFFICERS

Section 1. The President shall preside at all meetings unless he/she otherwise orders, and enforce all laws and regulations of the Association. He/she shall appoint all committees, unless otherwise ordered, and fill vacancies on any of the committees, and, as chief executive shall supervise the work and activities of the Association, and make a general report of such at the end of his/her term.

Section 2. The Vice-President shall perform the duties of the President in case of an absence or resignation of the President.

Section 3. The Secretary shall keep a full and complete record of the proceedings of all meetings at the Association's or Executive's meetings, and record all matters pertaining to the business of the Association which are deemed necessary. He/she shall conduct all normal correspondence of the Association, and shall issue all proper notices relating to the Association at any time requested by the Executive Committee.

Section 4. The Treasurer shall conduct all financial matters of the Association and receive all monies paid into the Association. All cheques for withdrawal of this money must bear the signatures of any two of the following officers; President, Secretary, or Treasurer. Any reports on financial matters must be given at any time requested by the Executive Committee.

Section 5. The Executive Committee shall conduct the business of the Association between general meetings when necessary.

ARTICLE VII MEETINGS

Section 1. The Executive Committee shall call at least one (1) Annual General Meeting of the Association during the 90 day period following the end of the Fiscal Year. The officers shall report on all matters pertaining to the fiscal year just completed, and present plans for discussion for the current fiscal year.

Section 2. Other general meetings will be held from time to time at the discretion of the Executive Committee and on notice from the Secretary.

Section 3. A quorum at a general meeting shall consist of seven members, of whom at least five shall be Caller Members. Any non-Caller members of the Executive shall be counted as Caller members for the purpose of quorum.

Section 4. Mail-in or email voting will be allowed for members unable to attend the Business Meeting in person.

Section 5. Meetings of the Executive Committee shall be called from time to time by the President or at the discretion of the Executive Committee to conduct Association business. A quorum at an Executive Committee meeting shall consist of four officers.

Section 6. The Order of Business at a general meeting of the Association shall be as follows:

1. Reading of the minutes of the previous meeting,
2. Report of Offices,
3. Report of Special Committees.
4. Unfinished Business
5. New Business.
6. Welfare.

ARTICLE VIII

AMENDMENTS

This Constitution may be amended only by a two-thirds majority vote of the fully paid members present at a general meeting of the Association and providing the proposed amendment has been submitted to the Executive Committee and a copy of the proposed amendment has been mailed to all members at least 30 days before the meeting at which the proposed amendment is to be voted upon.

ARTICLE IX DISSOLUTION OF THE ASSOCIATION

In the event of a motion for dissolution being presented, a special general business meeting would be convened by the Executive. In order for the motion to carry, a two thirds majority of members in good standing, in attendance at the meeting, and in favour of dissolution shall be required. If the motion of dissolution carries, three (3) trustees shall be selected from the membership to hold the association assets in trust for a period of six months (6 months).

During this period the trustees shall liquidate all association assets to cash, pay all liabilities, and donate the remainder of the funds to charitable organizations selected by a majority vote of members at the meeting for dissolution.

At the end of the six months (6 months) period, the trustees shall prepare a statement showing the final disbursements of funds, for distribution to all members in good standing at the time of dissolution.

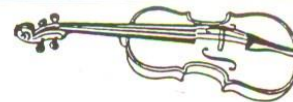
